WHEREAS, after the solicitation of competitive contracting proposals pursuant to N.J.S.A. 40A:11-4.1, titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), the Board of County Commissioners of the County of Burlington (the "Board"), awarded a contract, per Resolution #2021-00596 dated October 27, 2021, to America Works of NJ located at 790 Woodlane Road, Suite 7 & 8, Westampton, NJ 08060, to provide employment and training services to eligible Burlington County public assistance recipients of TANF Funding (Temporary Assistance to Needy Families), for a total amount not to exceed \$453,948.69 and for recipients of GA/SNAP Funding (General Assistance, and/or Supplemental Nutrition Assistance Program), for a total amount not to exceed \$293,429.35, for the contract period of November 1, 2021 through June 30, 2022, with two (2) one-year options expiring June 30, 2024, for the Department of Human Services, Division of Workforce Development Board; and

WHEREAS, the Department of Human Services, Division of Workforce Development Board recommends exercising the First Option Year for the contract titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), with America Works of NJ located at 790 Woodlane Road, Suite 7 & 8, Westampton, NJ 08060, to provide employment and training services to eligible Burlington County public assistance recipients of TANF Funding (Temporary Assistance to Needy Families), for an amount not to exceed \$669,522.62 and for recipients of GA/SNAP Funding (General Assistance, and/or Supplemental Nutrition Assistance Program), for an amount not to exceed \$432,774.87, for a total amount not to exceed \$1,102,297.49, for the contract period of July 1, 2022 through June 30, 2023; and

WHEREAS, the contract shall be charged to the proper account numbers, contingent upon appropriation of sufficient funds in the 2022 and 2023 temporary and permanent budgets; and

WHEREAS, the certification of availability of funds will be issued as needed, but prior to services being provided, by the Burlington County Chief Financial Officer or Treasurer; now, therefore, be it

RESOLVED, by the Board of County Commissioners of the County of Burlington, that the contract titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), be awarded for the First Option Year, to America Works of NJ located at 790 Woodlane Road, Suite 7 & 8, Westampton, NJ 08060, to provide employment and training services to eligible Burlington County public assistance recipients of TANF
